CHAPERONE & SKI FOR FREE!

Please check the box on the registration form if interested or contact the Rec. Dept. to sign up. You can choose which date(s) you are available to chaperone.

Four Bus Chaperones are needed for each trip to Bolton. Bus chaperones are required to arrive at the school at 2:45 to assist with loading and supervision during the trip. At Bolton, all chaperones must be available throughout the evening to help any child who requires assistance, and to provide supervision in the rental shop, cafeteria, and on the slopes. If you want to ski with the kids, you will be provided with a free lift ticket for the evening.

In addition to bus chaperones, we also need an Emergency Driver for each trip. This volunteer takes his/her own vehicle to the mountain and helps on site, but is available to drive a participant back if there is a special situation such as an injury or kid late for the bus departure.

Additional Parent Volunteers who meet the group at the mountain are encouraged and welcome. If you register as a volunteer with us, you will be eligible for a *discounted* lift ticket for the night. Free lift tickets are reserved for the bus chaperones and emergency drivers.

Our program depends on our volunteers! Please help if you can. All bus chaperones and the emergency driver will be required to have a background check in accordance with the Town's policy.

Please read carefully!

- We reserve the right to cancel the program if we don't reach our min. of 45 participants.
- There are **NO refunds** after the registration deadline.
- This program requires a large amount of independence from the participants. Parents should be aware of their child's emotional maturity to handle this program. They must be responsible for all of their equipment and able to make the bus on time. Participants need to ski with a buddy, as chaperones do not ski with the students. If you have any questions or concerns about this, please discuss it with our staff before registering your child.
- All participants must adhere to our behavior code on the bus and at Bolton Valley Resort. Students who cannot follow the rules may be removed from the bus or from the entire program without a refund.

Assumption and Acceptance of Risk, Release and Indemnity

I, _____, being aware that snowboarding, alpine, Nordic and freestyle skiing, tubing, mountain biking, horseback riding and such other recreational activities as Bolton Valley Resort may offer throughout the year are recreational activities carrying significant risk of serious personal injury, death or property damage and that there are natural, mechanical and environmental conditions and risks, which independently or in combination with such recreational activities may cause property damage, or physical injury, including severe or even fatal injuries to me or others, hereby **ASSUME** sole responsibility for such risks.

I also acknowledge that I am alone responsible for: (a) my safety while participating in any and all such recreational activities while on Bolton Valley Resort premises or when otherwise engaging in the use or enjoyment of said premises or while going to or from said premises; and (b) providing, utilizing and maintaining the equipment necessary for the safe enjoyment of my participation in such activities. In consideration for Bolton Valley Resort's permission to engage in any such activity, I hereby **RELEASE** and **HOLD HARMLESS** the owners and operators of the Bolton Valley Resort, including Mountain Operations and Development Corporation and Bolton Valley Resort, Inc. and their agents, representatives, officers, directors and employees in advance, from any and all liability whether foreseeable or unforeseeable resulting from my participation in any such activity, including any such claims regarding the design or condition of any equipment utilized by me in such pursuits without regard to whether such equipment is specified or recommended by such persons or entities identified herein.

To the extent I am also participating in any such activity which is promoted, sponsored or organized by any individual or entity other than those mentioned above, I also release any such promoter, sponsor, organizer, or club and their agents, representatives, officers, directors and employees from such liabilities and claims as well.

I further agree to forever **HOLD HARMLESS** and **INDEMNIFY** all person and entities identified above, generally and specifically from any and all liability for death, personal injury or property damage, resulting in any way from the aforementioned activities and uses or enjoyment.

I further agree that my privileges may be revoked by any representative or employee of the aforementioned persons and entities without refund at any time for misconduct, misuse, or nuisance.

If my ward or child is participating in above activities, I understand that it is my or my parent or guardian's sole and exclusive responsibility to provide valid and sufficient medical and accident insurance to cover medical or other injury or illness costs that may result from the aforementioned uses and enjoyment. I release all persons and entities identified above from providing this coverage for me.

I agree that I will accept and abide by the rules and regulations of the owners and operators of the Bolton Valley Resort and any other rules or regulations imposed by the promoters, sponsors and organizers of any particular activity. This Acknowledgment and Assumption of Risk and Release shall be binding upon my heirs and assigns.

By signing this Acknowledgment of Risk Release and Indemnification as Parent/Guardian, I authorize and consent to my ward or child's participation in the above-described activities and acknowledge that I understand that any and all risk whether known or unknown, is expressly assumed by me, and all my claims whether known or unknown are expressly released in advance pursuant to the terms hereof.
